President's Corner

Spring is almost upon us and, for aviators, that means good weather and more flying. Thus for our chapter also, as we have an uptick in activities and events as spring gets going. Let's go over a few of these coming attractions.

First off, beginning in April, we will move our monthly member meetings back to the chapter hangar. We had four months of Cattlemens which I thought worked out nicely, but we do have different kinds of meetings at Cattlemens vs. what we have at the hangar. It's a different environment and we have a bit more latitude in our meeting structure.

Also in April, we return to support our friends at the Lincoln Regional Aviation Association (LRAA)...many of us are members too of LRAA. But, with the LRAA display day on the third weekend of each month, our chapter will provide a pancake breakfast alongside the LRAA display day. All proceeds from the pancake breakfast support our Aviation

Scholarship program. We are spending a good chunk of money out of the program to send two young people to the EAA Air Academy this summer, so we need to replenish our fund to help send some more next year.

Also, a bit of a different event will be held on Saturday, April 13. This will be a chapter-sponsored Airport Fun Day. We will be having a hot dog lunch but, more importantly, we will be offering activities for the whole family with an emphasis on youth. We want to spread the word on what our chapter is doing and provide some information about the opportunities of aviation.

It is no accident that the Airport Fun Day is three weeks before our chapter's next Young Eagle Rally. Beginning March 26, we are accepting sign-ups for Young Eagles to get a ride in a plane, as well as sign-ups for pilots and volunteers to help out. It is our intent to fly 80 kids at this Rally...broken down into 20 kids in four blocks of 90 minutes each. This will be our third Rally in the prior 12 months...the other two Rallies were filled to capacity and we expect the same this time around too.

So, looking at the big picture, we are quickly spinning up the activity turbine for April and early May. Lots of opportunities for jumping in and helping make these events, our chapter's events, a success. This should be a fun season for our chapter. And, we have just the right place for all our chapter members to join in on the fun.

You want to go where everybody knows your name, or so they say. But it is apparent that some older dudes have trouble just remembering their own names and thus cannot be expected to remember much else.

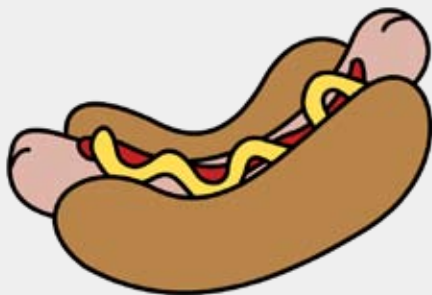
New individual and family members will be provided with one name tag by the chapter. To offset the cost of the name tags, first year membership dues will increase to \$25 for individual membership and \$35 for family memberships. After the first year, the dues will revert to the standard \$20 and \$30 respectively.

Additional name tags for family members can be purchased for \$7 each, prepaid at the time of ordering. Gold members will be provided with one gold name tag as part of that membership level. Cool.

Airport Fun Day Scheduled for Saturday, April 13

Chicken Shot

EAA Ray Aviation Scholarship

Our chapter applied earlier this year to participate in the new EAA Ray Aviation Scholarship program whose goal is to distribute a grant of \$1 million in the form of \$10,000 flight training scholarships that will be administered by individual chapters. As this newsletter is being finalized, we heard back from the EAA qualifying committee. We were happy to hear that our chapter did qualify for the program... our application was ranked at 100 out of 231 applicants. However, the \$10,000 scholarships are going to the top 90 chapters only so, until more funding is made available, we will not be able to bring forth a candidate at this time. Our chapter leadership is still absorbing the details of the EAA response to our application and will continue to pursue the participation of our chapter in the Ray Aviation Scholarship. Board Member Erika Wallin is our Scholarship Coordinator for the program.

New Chapter Board Member

At the March chapter board of directors meeting, chapter member Dan Masys was elected to the board to replace Bill Wooton, who had to resign in January due to time conflicts. Dan brings a wealth of experience with him to our chapter board based on his significant involvement with two other EAA chapters. Dan moved last year from Washington State with his wife Linda to the Lincoln area, bringing their RV-10 and RV-12 with them, Dan will serve out the board term which ends in December 2019.



City explores options for airport's \$6.4M debt

Lincoln's Finance Department is undergoing a staff-described "overhaul" and on the list of items to be remedied are the city-owned Lincoln Regional Airport financials. As of June 2017, the airport has amassed a \$5-million loan debt in borrowed funds, according to the most recent annual audit that analyzed the 2016/2017 city finances. An additional \$1.4-million in interfund loans brings the total balance to \$6.4 million in the red.

"The airport does not have the revenues to repay the debt it is carrying," said Airport Committee member and Mayor Paul Joiner.

The result has been a years-long practice of interfund borrowing that is not compliant with the city's own standards, according to staff. Lincoln Interim City Manager and acting Finance Director Jennifer Hanson said the \$5 million amount is a short-term loan that is not in line with proper accounting methods. The other \$1.4 million is in the form of an interfund loan related to the financing of an airport hangar project, according to Hanson.

"I believe it's a problem that's been building and it just hit an inflection point," said Airport Committee chairman Richard Pearl.

Hanson said that the immediate need to address the city's interfund processes has brought the issue of the airport's finances into the forefront in a way it hasn't previously. The city has shored up the airport's more immediate operational debt by increasing revenue and decreasing expenses related to its labor and fuel operations, according to Hanson.

"What we haven't been able to do is make a dent in the previous debt and that keeps compounding," Hanson said.

The audit found that the airport's enterprise fund does not have a demonstrated ability to repay the \$5 million in borrowed funds.

Additionally, an analysis of the airport's financials conducted mid-February by the city's contracted financial consultant Stephanie Beauchaine characterized the airport's operating

fund as "essentially insolvent." In summary, Beauchaine wrote the fund has \$6.4 million in borrowed funds, debts in excess of assets of \$510,000 and "only has 6.9 days of working capital on hand."

Hanson said the practice of non-compliant interfund borrowing will not continue and that the city's comprehensive interfund loan processes are currently undergoing staff review before the issue is presented to council within the fiscal year. Next steps to rectify the airport committee's debts are now being discussed amongst city staff and advisory Airport Committee members in ongoing public meetings, the next scheduled for March 20 at City Hall.

"It's going to be a combination of reducing expenditures, increasing revenue, and possibly the selling of some of the assets that the airport currently owns," Hanson said.

One of the first steps in the city's preliminary plan to reduce expenditures is to cut staffing and reduce full-time staff from two to one employee. Hanson said the staffing change will impact the operation hours of the airport but will still allow full-time service.

"Over the last few years, we've been working diligently to stop the bleeding at the airport and I think we've got that fairly well-handled," Joiner said. "Moving forward, we've got to take a look at that long-term liability of debt that has built up over the past couple of decades."

Pearl said cutting costs won't singularly solve the problem and he wants to focus more on growing the airport and hiring a professional management company to take over. Other options suggested by staff include privatizing services, implementing a public-private partnership, better leveraging fuel costs and leasing land to private entities.

Joiner said the city's financial outlook has improved enough for the city to begin to address the airport's debt. "I think we're look at this more directly now than we ever have," Joiner said.
